## A. ERNESTINA BACA, PROJECT SPECIALIST, SANTA FE SOLID WASTE MANAGEMENT AGENCY.

Ms. Baca said the first Saturday of the month, from February to November, will be Free Electronic and Household Waste Day. For the first six months, our numbers have far exceeded prior years. The first weekend of every month is Free Tire Day. The first six months of tire collection also have exceeded prior years. Free Trash Day will be on July 20<sup>th</sup> from 7:00 am to 1:00 pm at the Caja Del Rio Landfill only. The fall Free Trash Day will be on September 21<sup>st</sup> from 7:00 am to 1:00 pm at both the landfill and BuRRT. We are posting notices and are advertising in the Santa Fe New Mexican.

## B. DEBORAH TRUJILLO, INTERIM DIVISION DIRECTOR, CITY OF SANTA FE ENVIRONMENTAL SERVICES DIVISION.

Ms. Trujillo said we will be giving our recycle drop off centers on Lucia and Agua Fria updates such as fencing and bigger containers. We will also have additional staff out there to educate customers that these drop off centers are for recycling only. The update work should start at the beginning of August.

Commissioner Hansen said the residents along Agua Fria complain regularly about that site. People leave anything there. She is looking forward to the improvements.

Councilor Lee Garcia said he is right next to the Lucia drop off. He gets complaints about the fence and the upkeep.

Ms. Trujillo said we will be replacing the entire fence.

Councilor Lee Garcia asked Ms. Trujillo to keep him updated so he can let his constituents know what is going on.

## C. LES FRANCISCO, SOLID WASTE SUPERINTENDENT, SANTA FE COUNTY PUBLIC WORKS

Mr. Francisco said all our collection centers are up and running to full capacity. We will be doing a clean up on County Road 34 next Monday.

Chair Bustamante said thank you all for your good work. We appreciate it.
