- IX. MATTERS FROM STAFF AGENCY, CITY, COUNTY

Ms. Boettner said we held the following free days in July: e-waste, green waste, tires, and trash. The counts were in line with the previous months. We also had a free trash day at Caja Del Rio. The counts there were also in line with the previous month. We are going to hold free tire days on September 7<sup>th</sup> and 8<sup>th</sup>; green waste on September 7<sup>th</sup> and 8<sup>th</sup>, e-waste and HHW on September 7<sup>th</sup>. Those events will all be held at BuRRT. We will have a free trash day at both BuRRT and Caja Del Rio on September 22<sup>nd</sup>.

Commissioner Greene asked about the marketing of the events and suggested that the liaisons and others be sent the flyers for distribution.

Ms. Boettner said they are all advertised on our website, Next Door and on Facebook. We hand out flyers at both facilities. Let us know if you need flyers.

Mr. Boettner said she wanted to let the Board know that the Municipal Waste Management Association Fall Summit is happening in Santa Fe in conjunction with the Conference of mayors. It will be held at the Hilton Santa Fe on September 10<sup>th</sup> - 12<sup>th</sup>. She encourages everyone to attend.

Mr. Kippenbrock commented that this is a great event and provides a lot of information. We were a member of the Association in the past and may become a member again.
